APPLICATION PROCESS

STAGE 2

Offer Letter will be generated by the Employer and It will go through a Labor Market Assessment.

STAGE 3

Once we get the Approval on Labor Market Assessment, Your Work Permit will be issued immediately.

STAGE 4

After getting the work permit you have to apply for a visa and once visa is granted, you have to land in Europe.

STAGE 5

Once you go to Europe on a Work Permit, we will file an application for an EU Residence Card called (TRC - Temporary Residence Permit - after completion of six months) you have access to move freely, travel to all EU countries. You are required to stay in contact with our lawyer to coordinate on getting proper and regular advice on how to maintain your residence permit.
